6. Requests for special time considerations must be in writing before the entry deadline. We will try to honor requests. If we cannot accommodate your time request, we will return your entry fee. No time requests if playing 3 events.
7. No refunds after the entry deadline.

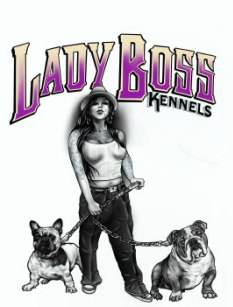
